6 WORKING GROUP REPORTS

6.1 P2895 – Standard Taxonomy for Responsible Trading of Human Generated Data

Report distributed prior to the meeting. Angelo provided additional information.

- It is expected that number of WG members will pick up.
- The confusion between the WG, task group and sub-groups is being resolved.
- It is proposed to have a P2895 workshop at ISTAS2022
- Concern was expressed with the use Trading in the title of the PAR. It may be possible to change the title without having to resubmit the PAR.
- Discuss was held about "trading". It was noted that trading is contextual, and data exchange can/could be considered trading. An associated issue is who owns the human data, the human, the host, or collector of the data.
- The issue of overlapping/interacting standards was raised. It is not clear who is responsible for the setting of boundaries between standards and ensuring that separate standards do not produce conflicting requirements/definitions.

6.2 P7012 – Standard for Machine Readable Personal Privacy Terms

Report distributed prior to the meeting. The SC agreed that the use of ISO Knowledge Representation was the correct approach.

Christy is developing a liaison overview for the WG.

7 PROPOSED PARS

7.1 P3176 Standard for an mHealth Ecosystem of Equity

P3176 Standard for an mHealth Ecosystem of Equity has been removed from NesCom submission as additional work is needed to finalize the PAR.

7.2 Recommended Practice for the Responsible Design and Development of Neurotechnologies

Awaiting approval at September meeting of NesCom. Chair approved in myProject. P7700 number has been allocated to this PAR as it may be the first in a series.

7.3 Recommended Practice for Addressing Sustainability, Environmental Stewardship and Climate Change Challenges in Professional Practice

Awaiting approval at September meeting of NesCom. Chair approved in myProject. P7800 number has been allocated to this PAR as it may be the first in a series.
